Bail Reform Went Into Effect January 1, 2020, And, With Close To Nine Out Of 10 Cases Made Ineligible For Bail,1 Contributed To A 40 Percent Decline In New York City's Pretrial Jail Population. Elsewhere In The State, The Impacts Were Even Slightly Larger. The Reforms Were Then Amended April 3, 2020, With An Effective Date At The Outset Of May 6th, 2024
